Chief Kohany thanked the member who attended services for Ex-Chief Joe Primerano, Sr.; reminded members to wear masks at all department activities and continue to follow Covid-19 protocols.

Comr. Ciancio reported new TL49 has been delivered and radios will be installed on 3/11; reviewed procedures for physicals – there was a discussion on protocols for physicals; suggested and recommended suspending drilling on hydrants until the Hydrant Agreement with the Town is settled; advised members to not drill on private property and do not record and post on social media; FEMA reimbursement project is in process; there was a discussion on working better together as a department; discussed VFC #1 letter on Covid-19 protocols.

Comr. Deegan reported the 2020 Service Award certifications have been completed by both companies and will be sent to the actuary.

Comr. Bonanno reported members were measured for new uniforms; spoke with the Town on the broken hydrant at Zeiss and is working on protocols for it.

Comr. Sciliano reported progress.

Comments from the floor:

Captain McGuinn asked for clarification on opening hydrants at a call; discussed 5" hose on new Engine 81; VFC #1 feels animosity because they don't ask for equipment but feel it is pushed upon them and they are expected to be grateful for it; several VFC #1 members require SCBA face pieces.

With no other business to come before the Board of Fire Commissioners, it was moved on a motion made by Comrs. Bonanno/Sciliano to adjourn the meeting at 8:27pm. MC.
