CHIEF'S REPORT

It was moved on a motion made by Comrs. Ciancio/Lester to accept the Chief's report for December 2024. MC. Activity report for November 2024: alarms 36 for 275 hours; 7 drills for 170 hours; 2 meetings for 74 hours; misc. 8 for 43 hours; 2 fire prevention for 6 hours. Total hours 578.

Asst. Chief DiPrinzio reported Blue Santa visit 12/17 hosted by the County PD and DES; visited Blythedale; members participated in the Girl Scouts tree lighting; members attended Sean Carroll Seminar at Thornwood FD; Chris Lester qualified on R59 and Captain Kohany qualified on TL49; working with Chief Olson TFD on radio and department response at new development behind Rosehill Shopping Center; Elmwood Hall alarm issues due to moisture collecting in the building; Ronald McDonald House reported fire was a miscommunication between security and the department; Chief's cars still not completed as they are waiting for gear safety boxes to be received and installed.

COMMITTEE REPORTS

Comr. McCarthy reported generator at VFC #1 will be repaired 12/16; suggested a lock box at VFC #1 with physical key in the event the key fob system goes down; battery back-up install at VFC #1 is in process; E81 will be repaired and serviced in January and E82 and E84 will follow.

Comr. Ciancio reported R59 has returned from being refurbished; discussed the dates for the Chief's Nominating meeting and Commissioner Election are the 1st Thursday and 2nd Tuesday, respectively, as set by NYS law; Patrol12 to be used for wedding photos in Ossining in December.
