It was moved on a motion made by Comrs. Ciancio/McCarthy to accept the Chief's Report as read. MC. Activity Report for December 2024: 42 alarms for 420 hours; 3 drills for 45 hours; 2 meetings for 48 hours; 21 misc. for 162.50 hours. TOTAL: 676 hours.

Chief DiPrinzio reported 12/3 FAST responded to Port Chester; 12/8 TL49 responded to Briarcliff; 12/10 mutual aid call to Grasslands for a HAZMAT call; 12/15 TL49 relocated to Fairview; 12/31 FAST responded to Sleepy Hollow; 12/7 Santa visit to Blythedale; 12/9, 12/10, 12/12 members participated in annual Santa visits; 12/17 members participated in Blue Santa with WCPD; thanked the Board and members for working together the last year; congratulated Asst. Chief and officers; continuing to work towards 'department first' vision; Radio aliases have been changed with the county; met with Goosetown on portable radios and discussed WMC issues; sprinkler system in WMC parking garage has been drained for the season; Elmwood Hall sprinkler system shut down due to heating issue; ConEd inquired with MPPD about the FDs that have generators and transfer switches; Lt. Sten attended meeting with Bee Line Bus; monthly inspections will begin for MA1; Thornwood FD testing at new senior building; contacted AAA Emegency about training new members as bailout trainers; Chappaqua FD reached out about a live fire training; requested to change mutual aid assignments back; requested permission to create an additional account on RedNMX for dispatch; will be hosting a department meeting 1/13 – requested the Board provide food; 1/15 engines will begin going for annual service.

Asst. Chief McGuinn requested the purchase of updated Fire Officer II 6th edition book; requested a copy of the hose and ladder testing.

COMMITTEE REPORTS

Comr. McCarthy reported generator at VFC #1 needs additional repair and is looking into a new generator company; received lock boxes for physical keys at each building if the key fob system goes down; delivery of trailer for MA1 is backed up; Engines will begin annual service on 1/15; will get tires from Corsi for E84; contacted Klahr Glass to get an estimate for building additional office within district location; asked Chiefs to have recalls fixed on their district vehicles.

Comr. Ciancio reported the fit test machine is still not working and needs to be repaired or replaced – members should continue to get tests done at AAA Emergency; visited Goosetown on the new radios and they will provide training when the radios are delivered potentially at the end of January; asked for a status of members who completed bailout for 2024 to continue as interior; ordered 45 new pagers through Rockland County state contract pricing; 4/25 scheduled CPR/AED training; received ladder testing report for TL49; will contact Morningpride to arrange for measurements for VFC #1 members that need new gear; discussed status of new Chief's cars.

Comr. Bonanno reported he will purchase 25 and 50-year badges for members; asked Captains to provide names of active members that need new uniforms; will schedule Defensive Driving course for March.

Comr. Sciliano tree trimming has been completed, waiting for invoice.

There was a discussion on scott packs and various other equipment needed or requested for engines.

It was moved on a motion made by Comrs. Ciancio/Bonanno to write and send \$69,000 check to Ameriprise per the budget. MC.

It was moved on a motion made by Comrs. Bonanno/McCarthy to approve the termination of Paul Mardjonovich from VFC #1. MC.

It was moved on a motion made by Comrs. McCarthy/Ciancio to authorize the Secretary-Treasurer to purchase the updated Fire Officer II book. MC.
